#### **ABOUT GUAM COMMUNITY COLLEGE**

Guam Community College is a multi-faceted public career and technical education (CTE)/vocational education institution, created by the Community College Act of 1977 to strengthen and consolidate career and technical/vocational education on Guam. The College operates secondary and postsecondary CTE programs, adult and continuing education, community education, and short-term specialized training, as dictated by community and industry needs.

These programs are delivered both on and off-campus (in satellite programs at Guam's public high schools) and on site at businesses as needed. The College also serves as the State Board of Control for Vocational Education under the United States Vocational Education Acts of 1946, 1963, and subsequent amendments.

#### INSTITUTIONAL STRATEGIC MASTER PLAN

In March 2009, in order to guide GCC in meeting the challenges that the impending military buildup will bring to our island's workforce, the College launched Moving Forward: Institutional Strategic Master Plan, 2009-2014.

We introduced our ISMP to key community stakeholders: members of the Guam Legislature, government agency directors, consuls general, and current and potential business partners.

Almost immediately, GCC began implementing the four major initiatives of the plan: Pioneering, Educational Excellence, Community Interaction, and Dedicated Planning, through measures such as curriculum expansion, physical plant improvements, community outreach, and self-assessment reports. GCC offers over 50 fields of study, and prepares students for entry-level employment in career and technical fields or transfer to four-year institutions of higher education. Also, the College offers a variety of community service and special programs to prepare students for college, including English as a Second Language, Adult Basic Education, General Education Development (GED) preparation and testing, and an Adult High School Diploma program.

The College expanded its curriculum during the year to include the following new programs:

- Associate of Science Surveying Technology
- AS Criminal Justice concentrations: Forensic Computer Examiner and Forensic Lab Technician
- Certificate in Medium/Heavy Truck Diesel Technology In addition, the College revamped the Certificate in Construction Technology, which includes seven concentration areas: carpentry; electricity; heating, ventilation and air conditioning; masonry; plumbing; reinforcing metal worker; and welding.

#### **ENROLLMENT**

During Fall Semester 2009, GCC experienced a record enrollment increase of 18.75 percent, growing from a student population of 1,835 in Fall 2008 to 2,262 students on its campus in Fall 2009. Fall 2007 enrollment stood at 1,794 students. As competition for the jobs associated with the military buildup increases, GCC expects its student population to continue to grow as well.

#### **ACCREDITATION**

Guam Community College is an accredited institution under the Accrediting Commission for Community and Junior Colleges (ACCJC), Western Association of Schools and Colleges (WASC). Guam Community College has been continuously accredited since 1979 by ACCJC/WASC. Documents describing the accreditation of the College may be examined at the Academic Vice President's Office. The Registrar may also be contacted for further information or to make arrangements to examine the accreditation documents. With the recommendation of the Curriculum Review Board of the American Association of Medical Assistants (AAMA), GCC's Medical Assisting program has been accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP) since 2003.

### **Our Finances**

At the April 2009 Board of Trustees meeting, a resolution was passed to suspend tuition and fee increases scheduled for Fall 2009 at the request of our students and in light of the economic struggles currently facing a majority of our island's population.

For the ninth consecutive year, GCC has maintained its low-risk auditee status rendered by independent auditors Deloitte & Touche. A review of the college's financial records demonstrated there were no questioned costs or unresolved prior year audit findings in fiscal year 2009. Proudly, the college continues to receive recognition by the Office of the Public Auditor as one of the best financially managed organizations within the Government of Guam system. The college strives to maintain this status, and remains committed to displaying fiscal responsibility in the management of its funds by operating within authorized levels.

#### **REVENUES**

At the end of FY 2009, the net assets of the College increased by approximately \$4 million. The increase was due to increases in tuition revenues of approximately \$500,000, a nearly \$1 million sub-grant from US Department of Interior for the Allied Health Center, an increase

in local appropriation from the Manpower Development Fund of \$500,000, and increases in other federal and local grants.

#### **EXPENDITURES**

Expenditures remained fairly stable in comparison with prior years as for the first nine months of the fiscal year, the college received on average only 50 percent of its local appropriation. This required the operational reduction of contractual services and strict management and control over GCC resources in order to deal with the cash shortages.

## **Our Outlook**

GCC is expanding its programs, services and buildings so that members of the local community will be able to acquire the skills and training needed to compete for the increased job opportunities that the military expansion will bring to our island.

GCC is partnering with federal and local government entities as well as private sector businesses to ensure that Guam's workforce becomes an integral part of the island's growing economy.

In the past two years, as enrollment at the college has skyrocketed, GCC has added three new buildings to its campus. In October 2009, the college broke ground for its new Learning Resource Center – the first LEED-certified building for the government of Guam. The LRC is scheduled for completion in December 2010. Our new Anthony A. Leon Guerrero Allied Health Center opened in December 2009, and houses our pre-and practical nursing programs, our medical assisting program, and our science labs. In June 2010, GCC broke ground for a new Student Center, which is scheduled for completion in summer 2011.

GCC's sustainability efforts include having been awarded a \$1.2M sub-grant from the Guam Environmental Protection Agency for an energy audit that will allow our campus to become more energy efficient. The \$1.2 M sub-grant was in addition to \$9.2M in American Recovery and Reinvestment Act (ARRA) funds granted to GCC in FY 2009 for the following projects: a new Student Center, completion of the Learning Resource Center, additional parking lots, a VoIP telephone system, generators, integrated system software, an automotive paint booth, and a fire sprinkler riser.
